- 8. Student must submit migration certificate last attended University.
- 9. The admission being granted is purely provisional and is subject to the total compliance with the eligibility criteria and the submission of all the certificate / Documents and is also subject to confirmation by the college authority.
- 10. Registration form and Deposition of Minimum Registration Fee (Rs. 15,000/-) is Compulsory.
- 11. After Registration and Deposition of Registration fee your seat will be deemed as confirmed.
- 12. Minimum Tuition fee for the Management Quota will be Rs. 65,500/- per year.
